Treasurer Report – Scott Murayama

- General Account balance

- Casino Account balance

- E-Transfer Account balance
 - \$1,345.29 as of December 1, 2025

- December 2025

Motion to approve \$2,000.00 to help purchase equipment for the Jr Football team by Tavis, 2nd by Maria. No one opposed, Motion Carried

Funding Review – On Hold

- June 2025
 - Custom Sports Chairs requested \$18,000.00 to purchase 50 custom NTHS chairs. Chairs would be used for all athletic home games, ceremonies, presentations, professional development. In June, the decision was to get more information on any RAM Funding, could we order less than 50 chairs, do we need a cart.
 - November: Mr. Bester to investigate another vendor. Will bring to December meeting for discussion
 - **December: Revisit in February**
- November 2025:
 - Rooftop Garden requesting \$390.00 for foldable stools. Decision is to table to the December meeting
 - **December: Revisit in April**
